RESOLUTION AUTHORIZING INTERVENTION IN PROPERTY TAX ASSESSMENT APPEALS

At a duly called and noticed public meeting of the BOARD OF LIBRARY TRUSTEES OF THE WOOD DALE PUBLIC LIBRARY DISTRICT, ("Taxing District") held on the 17th day of April, 2017 at 140 School Street, Wood Dale, County of DuPage, State of Illinois;

The meeting was called to order by <u>Barbara F. Dunn</u>, President of the Board of Library Trustees, and upon roll being called, the following members were:

The following Resolution was offered by Krebasch, and seconded by Sparacio, and seconded by Sparacio.

WHEREAS, the Taxing District receives statutory notice from the Board of Review of DuPage County of property tax assessment appeals filed by taxpayers with the DuPage County Board of Review and the Property Tax Appeal Board ("PTAB"), or other notice regarding Specific Objections filed with the Circuit Court of DuPage County regarding

the assessed valuation of property which comprises part of the assessed valuation of

the Taxing District; and

WHEREAS, the Taxing District has a revenue interest in such property tax assessment appeals and finds that intervention as a party in such proceedings is in the best interests of the Taxing District; and

WHEREAS, the Taxing District has a right to intervene in proceedings before the Board of Review, PTAB, and the DuPage County Circuit Court in order to protect its revenue interests in the assessed valuation of the subject properties;

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF LIBRARY TRUSTEES OF THE WOOD DALE PUBLIC LIBRARY DISTRICT as follows:

1. The Board of Library Trustees finds that all of the recitals contained above are true and correct and that the same are hereby incorporated herein by reference.

- 2. The law firm of Robbins Schwartz is authorized, as of the postmark date of the Board of Review notice of property tax assessment appeals, to file as legal representative on the Taxing District's behalf a request to intervene in the property tax assessment appeals filed before the DuPage County Board of Review and the PTAB.
- 3. The law firm of Robbins Schwartz is authorized to file as legal representative on the Taxing District's behalf a request to intervene in the property tax assessment appeals filed with the Circuit Court of DuPage County.
- 4. All motions and resolutions or parts thereof in conflict with the provisions of this Resolution are, to the extent of such conflict, hereby repealed.
- 5. This Resolution shall take effect immediately upon its passage.
