**III. Public Hearing as to the Budget and Appropriation Ordinance – Ordinance #7 2016 for the Wood Dale Public Library District July 1, 2016 – June 30, 2017**

Vice President Matuszewski opened the Public Hearing as to the Budget and Appropriation Ordinance – Ordinance #7 2016 for the Wood Dale Public Library District for July 1, 2016 – June 30, 2017 and read the following opening statement:

“Section 1: This is Public Hearing as to the Budget and Appropriation Ordinance- Ordinance #7 2016 for the Wood Dale Public Library District for the Fiscal Year Beginning July 1, 2016, and Ending June 30, 2017.

Section 2: In accordance with Illinois Statutes, the Wood Dale Public Library District published a “Legal Notice” of the public hearing on Wednesday, August 17, 2016. This notice was published in the DuPage County Chronicle which is circulated throughout DuPage County and the surrounding area.

Section 3: The Ordinance in Tentative Form (Tentative Budget and Appropriation Ordinance – Ordinance #6 2016) was available for public inspection for at least thirty days prior to this hearing in the Main Library Lobby posting board at 520 North Wood Dale Road, Wood Dale, Illinois and the Administrative Office at the Library Programming Center at 140 School Street, Wood Dale, Illinois.
