Acceptable Materials

- Aerosol cans
- Asbestos materials (sized to fit in a 55-gallon drum; not in excess of 50 pounds)
- Automotive fluids (oil, gasoline and anti-freeze)
- Batteries (automotive, marine and sump pump)
- Fire extinguishers
- Flammables
- Fluorescent bulbs, CFLs (sealed, unbroken only)
- Household cleaners, drain openers and pool chemicals
- Mercury
- Non-controlled prescription and over-the-counter medications
- Paints and stains (oil-based only)
- Peanut oil
- Poison, pesticides and fertilizers
- Propane tanks
- Solvents and strippers
- Thermostats
- Unknown hazardous substances

Materials Not Accepted

- Ammunition
- Compressed gas (other than propane)
- Electronics
- Empty spray cans and containers
- Explosives
- Helium tanks
- Latex paint
- Paper, glass, metal, wood and Styrofoam
- Radioactive materials
- Sharps (needles or lancets)
- Smoke detectors
- Tires
- Trash and non-hazardous materials
- Unopened, useable consumer products

CLOTHING & TEXTILES: DuPage County has partnered with eWorks and [RewearAble](#) to collect clothing and textiles for reuse and recycling. Items not able to be reused will be turned into cleaning/painting rags or reused in insulation, packing material and carpeting. RewearAble is a non-profit that provides sustainable employment for adults with disabilities.

Acceptable items: clothing, sheets, bedding, towels and other Household textiles in any condition. No heavily soiled items.



ELECTRONICS: DuPage County has partnered with eWorks and RLG to collect and recycle electronics responsibly.

Acceptable items: computers, laptops, servers, computer monitors*, televisions*, printers, facsimile, scanners, VCR and DVD players, video game consoles, cable and converter boxes, satellite receivers, electronic keyboards, mice, portable music players, holiday string lights, wire, cables, adapters, power supplies, cell phones, modems, tablets, phones, docking stations. visit website for a complete list of items.
